Sub: Consolidated Scrutinizer's Report on remote e-voting / e-voting conducted at the Extraordinary General Meeting (EGM) of the Members of the Handloom Export Promotion Council ('the Council'), held on Thursday, 3<sup>rd</sup> March, 2016 at 12.00 Noon at No.34 (Old No.18), Cathedral Garden Road, Nungambakkam, Chennai 600 034.

I, N.A. Srinivasan, Advocate & Corporate Consultant, have been appointed by the Board of Council of Handloom Export Promotion Council ('the Council') as a Scrutinizer for the purpose of scrutinizing the remote e-voting and e-voting facilities provided at the EGM venue, as per the provisions of Section 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time on the resolution set forth in the notice of the Extraordinary General Meeting (EGM) dated 9<sup>th</sup> February 2016, held on 3<sup>rd</sup> March 2016.

The EGM Notice along with statement setting out the material facts under Section 102 of the Act were sent to the Members in respect of the below mentioned resolution.

The Management of the Council is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and the Rules relating to voting through electronic means on the resolution contained in the Notice of Extraordinary General Meeting (EGM) of the members of the Council. My responsibility as a Scrutinizer for the e-voting process is restricted to presenting the Scrutinizer's Report for the votes cast in respect of the resolution stated below, based on the reports generated from the e-voting system provided by National Securities Depository Limited ('NSDL'), (the authorized agency to provide e-voting facilities, engaged by the Council).

The Council had also provided E-voting facility to the Members present at this Extraordinary General Meeting and who had not cast their vote earlier through remote e-voting facility.





Further to the above, I submit my report as under:

- The remote e-voting period remained open from Monday, 29<sup>th</sup> February, 2016 (9:00 a.m.) to Wednesday, 2<sup>nd</sup> March, 2016 (5.00 p.m.) on the designated website <u>www.evoting.nsdl.com</u>.
- The members of the Council as on the "cut-off" date i.e. 1<sup>st</sup> February 2016 were entitled to vote on the resolution as set out in the notice of the EGM of the Council.
- 3) After the conclusion of the e-voting at the Extraordinary General Meeting, the votes cast thereat were unblocked in the presence of two witnesses, who were not in employment of the Council.
- 4) The votes cast under remote e-voting facility were thereafter unblocked in the presence of two witnesses who were not in employment of the Council.
- 5) Thereafter, the consolidated details containing, inter alia, the list of Members, who voted in respect of the resolution that was put to vote, were generated from the e-voting website of National Securities Depository Limited (NSDL) (i.e.) <u>www.evoting.nsdl.com</u> and based on such reports generated, the result of the e-voting is as under:

To elect members to Executive Committee through e-voting process for all vacancies which were notified for election in the concluded 46th AGM held on 21.09.2015 and based on amended Articles of Association adopted by EGM in its meeting held on 30.01.2016.
