EXPORT PROMOTION ACTIVITIES 2017-18

EXHIBITIONS ABROAD:

1. Hong Kong International Home Textiles & Furnishings Fair, Hong Kong (20 - 23, April 2017)

Council participated in the 8th edition of the Hong Kong International Home Textiles & Furnishings Fair organized by Hong Kong Trade Development Council (HKTDC) at Hong Kong from 20-23rd April 2017.

HEPC participated with 27 member exporters by taking space of 264 sq. mtrs. and had also put up central pavilion stall in the fair. As per the feedback received from the participants, totally 417 business visitors visited their stalls and spot order worth Rs.6.75 crore and enquiries worth Rs.18.77 crore were generated at this fair.

The event was organised availing financial grant under Market Access Initiative (MAI) scheme of Ministry of Commerce & Industry, Govt. of India.

2. Global Indian Festival, Kuala Lumpur, Malaysia (31st May – 4th June 2017)

Council participated in the 15th Global Indian Festival, held at Kuala Lumpur, Malaysia from 31st May – 4th June 2017 with 10 registered holders of India Handloom Brand through India Trade Promotion Organisation. As per participants' feedback, totally 4000 visitors visited their stalls and a total business worth 0.80 crore was generated during this event.

The event was organized under National Handloom Development Programme of O/o The Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

3. Home Textile / Apparel Sourcing Expo, New York, USA (17 – 19, July 2017)

Council participated for the 5th time consecutively in the Home Textiles Sourcing / Apparel Sourcing Expo which was held from July 17-19, 2017 at the Javits Convention Center in New York, USA. The event is organized by Messe Frankfurt, Inc., USA.

HEPC participated in the event with 11 (10 with grant, 1 without grant) member exporters and had also put up Central Promotion stall. As per participants' feedback, totally 158 business visitors visited their stalls and a total business worth 4.11 crore was generated during this fair.

The event was organized under National Handloom Development Programme of O/o The Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

4. 28th India Home Furnishing / 38th India Garment Fair, Osaka, Japan (19 - 21, July 2017)

India Home Furnishing Fair organized by India Trade Promotion Organisation (ITPO) at Osaka, Japan is an ideal showcase for Home Textiles and is organized along with Indian Garment Fair to form Japan's largest comprehensive exhibition of Home Furnishing and Garments. Handloom Export Promotion Council has been participating in this fair for more than a decade. In this event held at Osaka, Japan during 19-21 July 2017, HEPC had participated with 27 member

exporters by taking constructed booth area of 294 sq.mtrs. and HEPC had also put up Central Promotional Stall in the fair.

As per the feedback received from our participants, totally 398 business visitors visited their stalls and spot order worth Rs.5.1 crore and enquiries worth Rs.8.1 crore were generated at this fair.

The event was organized under Market Access Initiative Scheme of Ministry of Commerce & Industry, Govt. of India.

5. Intertextile Shanghai Home Textiles, Shanghai, China (23 - 26, August 2017)

Council participated in the Intertextile Shanghai Home textiles, organized by Messe Frankfurt (HK) at Shanghai, China, from 23-26th August 2017 with 10 participants and had also put up a promotional stall in the fair by taking an area of 108 sq.mtrs. As per participants' feedback, totally 330 business visitors visited their stall and spot orders worth Rs.1.20 crore and business enquiries worth Rs.2.39 crore were received during this fair.

The event was organized under National Handloom Development Programme of O/o The Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

6. WHO's NEXT, Paris, France (8 - 11, September 2017)

Council participated in the Autumn edition of WHO's NEXT held at Paris, France from 8-11th September 2017. Council has been participating in this fair since 2010.

Council participated with 25 participants (20 with grant; 5 without grant) by booking space of 262 sq. mtrs. Council had put up a promotional stall. As per the feedback received from member participants, totally 425 business visitors visited their stalls and spot orders worth Rs.6.19 crore had been booked and enquiries to the tune of Rs.8.71 crore were generated during the event.

The event was organized under National Handloom Development Programme of O/o.The Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

7. India Trend Fair, Tokyo, Japan (27 – 29, September 2017)

The 3rd edition of India Trend Fair was organized in Tokyo by Japan India Industry Promotion Association during 27-29th September 2017. It was a B2B trade fair concentrating on fashion & textiles, bags & shoes, jewellery & accessories, interior and sundries.

Council participated in India Trend Fair, Tokyo, Japan from 27-29th September 2017 with 20 member exporters. As per the feedback received from member participants, totally 326 business visitors visited their stalls, spot orders worth Rs.4.61 crore had been booked and enquiries to the tune of Rs.12.32 crore were generated during the event.

The event was organized availing financial assistance under National Handloom Development Programme of O/o.The Development Commissioner (Handlooms), Ministry of Textiles, Govt. of

India.

8. International Sourcing Expo, Sydney, Australia (14 - 16, November 2017)

Council organized participation of 14 member exporters in International Sourcing Expo, organized by International Exhibition & Conference Group at Sydney, Australia during 14–16 November 2017. Total space of 144 sq.mtrs. was hired for stalls of member exporters and Council's central promotional stall at the fair.

As per participants' feedback, totally 413 business visitors visited their stalls and spot orders worth Rs.0.68 crore and business enquiries worth Rs.3.32 crore were generated during the event. Members reported that participation in this fair facilitated to gain entry into Australia and New Zealand.

The event was organized under National Handloom Development Programme of O/o The Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

9. Heimtextil, Frankfurt, Germany (9 - 12, January 2018)

Heimtextil is one of the biggest international trade fairs for Home Textiles and contract textiles. This fair is considered as the leading fair and attracts the buyers from more than 70 countries covering all the continents. The Messe Frankfurt is organizing this fair and HEPC has been regularly participating in this event for more than two decades. Out of more than two decades participation in Heimtextil, Council has been organizing participation in Heimtextil under MAI scheme since January 2011 onwards. India is the 2nd largest participant in this event next to China. As an average around 385 exhibitors which includes both direct as well as participants through EPCs from India exhibit in this event.

As a highlight of Indian participation in Heimtextil 2018, a ministry level delegation under the leadership of Smt. Smriti Zubin Irani, Hon'ble Minister for Textiles and Information & Broadcasting, Govt. of India visited the event. The delegation from Ministry included the following members

Hon'ble Minister inaugurated Indian Pavilion by cutting ribbon at TEXPROCIL stand which followed visit to Indian exhibitors stand in Hall 10.2, 10.3 and other halls.

Coinciding the visit of the Hon'ble Minster for Textiles and Information & Broadcasting, HEPC as a lead Council organised "India Eve" meet on 09-01-2018 in the esteemed presence of Hon'ble Minister as Chief guest. The dais was shared by Mr. Raj Manek, Managing Director, Messe Frankfurt Trade Fairs India Pvt. Ltd. and Shri. V.Kumar, Chairman, HEPC. The event was organised in coordination with Consulate General of India, Frankfurt and had the participation of TEXPROCIL and EPCH.

Around 70000 trade visitors from 135 countries experienced design innovations from 2975 international exhibitors at Heimtextil 2018. The visitors profile included representatives from the retail and wholesale trade, interior decorators, design, architecture and interior design and the hotel industry.

Council organized participation of 52 member exporters in Heimtextil fair held at Frankfurt, Germany during January 9-12, 2018. Council had hired total space of 1072 sq.mtrs. (726 sq.mtrs. in Hall 10.3 and 346 sq.mtrs. in Hall 6.3) accommodating 35 exhibitors in Hall 10.3 and 17 exhibitors in Hall 6.3.

As per participants' feedback, totally 1175 business visitors visited their stalls and spot orders worth Rs.20.25 crore and business enquiries worth Rs.46.65 crore were generated during the event.

Shri.Sanjay Rastogi, Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India visited the participants under the aegis of Council.

The event participation was organized under Market Access Initiative Scheme (MAI) of Ministry of Commerce & Industry, Government of India.

10. Domotex, Hannover, Germany (12 - 15, January 2018)

Council organized participation of 18 member exporters in Domotex held at Hannover, Germany during 12-15th January 2018. Total space of 246 sq.mtrs. was hired for stalls of member exporters and Council's central promotional stall at the fair.

As per participants' feedback, totally 400 business visitors visited their stalls and spot orders worth Rs.0.48 crore and business enquiries worth Rs.7.18 crore were generated during the event.

Shri.Rajesh Kumar Sahu, Additional Development Commissioner (Handlooms) and Executive Director (HEPC), visited the participants.

The event was organized under National Handloom Development Programme of O/o.The Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

11. WHOs NEXT, Paris, France (19 - 22, January 2018)

WHO'S NEXT fair is a premium fair for fashion and fashion accessories in Paris. The winter edition of WHO's NEXT fair was held during January 19-22, 2018.

Council participated in the winter edition of WHO's NEXT Show held at Paris, France with 11 participants on self-sustain basis and had also put up a promotional stall at the fair by taking an area of 134 sq.mtrs. As per the feedback received from member participants, totally 278 visitors visited their stalls and spot orders worth Rs.3.63 crore had been booked and enquiries to the tune of Rs.5.07 crore were generated during the event.

12. Pure London/Pure Origin, London, UK (11 – 13, February 2018)

Pure Origin takes place alongside the already well-established Pure London event. Pure London is an established and highly transactional fashion trade event attracting a powerful audience of senior decision makers across independent retailers, multiple retailers, online retailers and department stores. The event is held at the heart of the fashion industry in a stunning central London location uniting brands with manufacturers and textile producers all in one place. This event is organized by M/s.Ascential Events, UK.

Council organized participation of 7 member exporters on self-sustain basis in Pure London/ Pure Origin, held at London, UK during 11–13 February 2018. The event participation was organized the first time. Total space of 87 sq.mtrs. was hired for stalls of member exporters and Council's central promotional stall at the fair.

As per participants' feedback, totally 137 business visitors visited their stalls and spot orders worth Rs.0.73 crore and business enquiries worth Rs.1.87 crore were generated during the event.

Exhibitions in India:

1. Textiles India, Ahmedabad, Gujarat (30th June - 2nd July 2017)

Ministry of Textiles, Govt. of India organized Textiles India 2017 from 30th June - 2nd July 2017 at Gandhinagar, Gujarat, India's first ever mega textiles trade fair bringing global & Indian leaders together in one platform. Hon'ble Prime Minister, Shri Narendra Modi inaugurated the event on 30th June 2017 at the fair venue, Helipad Ground in presence of Smt. Smriti Zubin Irani, Hon'ble Minister for Textiles, Other Union Ministers, State Chief Ministers and dignitaries. Hon'ble Prime Minister in his inaugural address said that based on Make in India, the textile industry is being infused with the mantras of Skill, Scale, Speed & Zero-Defect, Zero-Effect. The Prime Minister also mentioned that Textile sector offers significant employment opportunities, being the second largest employer after agriculture and expressed hope that Textiles India 2017 would help familiarize global & Indian leaders with India's enabling policy environment, strengths & vast opportunities.

Addressing the gathering, the Hon'ble Minister of Textiles (HMoT) Smt. Smriti Zubin Irani said that history will be created in the field of textiles with the success of this mega event. HMoT hoped that Textiles India 2017 will give fillip to Honorable Prime Minister's dream of Make in India and lead to strategic partnerships that encourage investments in textile sector. She also specified that for this mega event global citizens from 106 countries, 15,000 Indian buyers and sellers, 2,500 international buyers, international delegates, artisans and weavers who enthrall with their craft have come together under one roof. The inauguration was followed by an international standard Fashion Show organized by the Ministry of Textiles.

Textiles India 2017 witnessed major events like 6 Conferences, B2B, B2G, G2G Meetings, Theme Pavilions, Country Sessions, State Sessions, 65 MoU Signing and 22 Roundtable Conferences apart from Exhibitions in 12 halls coordinated by various Export Promotion Councils spread over 78000 sqm.

During exhibition HEPC coordinated 3 Roundtable Conferences, 3 MoU signing and IHB Fashion Show during this mega event. The event had under the aegis of HEPC, 140 exhibitors from all over India including 8 designer exhibitors, 8 Indian Handloom Brand Exhibitors and 10 North East Exhibitors. Loom demo was also exhibited in the event. Special central promotional stand for Indian Handloom Brand, special country pavilion for Bangladesh were also coordinated by HEPC.

The exhibits covered main handloom products such as Table Linen, Mats, Kitchen linens, Floor coverings, Bed linens, Designer bags, Curtains, Cushions, Aprons, Handwoven Sarees, Stoles, Dupattas, Rugs, Jute shopping bags, Terry Towels, Carpets, Shawls, Pillow Covers, Mittens, Runners, Jute wall hangings, Quilts, Throws, Scarves, Tassar, Eri Silk, Ikat, Garments etc.

To the Members of HANDLOOM EXPORT PROMOTION COUNCIL

REPORT ON THE STANDALONE FINANCIAL STATEMENTS

We have audited the accompanying standalone financial statements of **HANDLOOM EXPORT PROMOTION COUNCIL ("the Company")** which comprises the Balance Sheet as at March 31, 2018, the related Income and Expenditure Account for the year then ended, and a summary of significant accounting policies and other explanatory information.

MANAGEMENT'S RESPONSIBILITY FOR THE STANDALONE FINANCIAL STATEMENTS

The Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Companies Act, 2013 ("the Act") with respect to the preparation of these standalone financial statements that give a true and fair view of the financial position, financial performance of the Company in accordance with the accounting principles generally accepted in India, including the Accounting Standards specified under Section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

AUDITOR'S RESPONSIBILITY

Our responsibility is to express an opinion on these standalone financial statements based on our audit.

We have taken into account the provisions of the Act, the accounting and auditing standards and matters which are required to be included in the audit report under the provisions of the Act and the Rules made there under.

We conducted our audit in accordance with the Standards on Auditing specified under Section 143(10) of the Act. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and the disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal financial control relevant to the Company's preparation of the financial statements that

give a true and fair view in order to design audit procedures that are

appropriate in the circumstances, but not for the purpose of expressing an opinion on whether the Company has in place an adequate internal financial controls system over financial reporting and the operating effectiveness of such controls. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the accounting estimates made by the Company's Directors, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion on the standalone financial statements.

OPINION

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid standalone financial statements give the information required by the Act in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2018, and its Income over Expenditure for the year ended on that date.
